TEN U.S. FIRE DEPARTMENTS SHARE \$100,000 AWARD FROM LIBERTY MUTUAL INSURANCE

Community Residents Rally to Earn \$10,000 Grants for Their Local Fire Departments by Committing to Fire Safety at www.BeFireSmart.com

BOSTON – November 18, 2010 – According to a recent survey by the National League of Cities, 14 percent of cities across the country cut police and fire-protection budgets in 2009, usually one of the biggest-ticket items for local governments, with many other cities expected to take similar measures through 2012 due to municipal budget shortfalls.
