The 893th meeting of the SNCA was held on August 7, 2024 at Rockin A Cafe. The meeting was being hosted by DRC. President Ocnaschek (BPD) called the meeting to order at 10:11AM

Tommy Wells recognized President Ocnaschek for recently being appointed Police Chief for the City of Beaumont. The membership responded with a standing ovation.

Self-introductions were made by those members present.

At the request of Chief White (BFD) President Ocnaschek asked the membership to stand and give a "Moment of Silence" of the recent passing of long-term Beaumont Fire Chief and SNCA member Chief Pete Shelton.

President Ocnaschek asked if there were any questions regarding the Treasurer's Report, there were none. President Ocnaschek then asked for a motion and second to accept the Treasurers Report as presented. A motion was made by Jody Herrera (Jeff. Co. ESD#3) and seconded by Stephanie Garsea (AEMS) there was no opposition to the motion, motion passed.

OLD BUSINESS:

• President Ocnaschek told the membership the Tentative 2025 Host Schedule has been put together and Secretary/Treasurer Gonzales has sent emails to the primary contact with those organizations informing them of their scheduled month to host. President Ocnaschek told the group if you are to host to make plans with the venue ASAP and let Secretary/Treasurer know so he can update the schedule and inform the membership.

NEW BUSINESS:

• President Ocnaschek began an explanation of some recent proposed changes to the Constitution, By-Laws, and Membership Dues Structure. The current membership structure does not specifically explain the response capabilities of agencies, only provide what the organization has in their inventory. The Industrial Fire & Safety Team has proposed to the Board to change this structure and categorizing each organization of what they can deploy to a SNCA called response. With this structure change, the IF&ST has also proposed a change to the dues structure reflecting that organizations deployment inventory. Some organizations have only minimal supplies and equipment i.e., oil spill boom and no response personnel to deploy to a SNCA called response. Other organizations have significant equipment inventory i.e., fire engines, pumps, trailer mounted monitors, etc., plus manpower who can be deployed if called upon. The thought behind the structure

change if you have less to deploy to an emergency your organization will have to pay more in dues than those organizations with larger inventories. After a lengthy explanation by both President Ocnaschek and IF&ST Chairperson McDonald there was no comments from the membership and it was assumed to be a consensus of the proposed changes.

Per the SNCA Constitution, Section 1, the Constitution may be amended by a majority vote of Voting Members present at any Monthly or Special Meeting provided the membership has been provided a copy thereof in writing or electronic means thirty (30) days prior to the meeting. At the September meeting this topic will be reviewed and then brought to vote by the membership.

- President Ocnaschek then called on Chairperson Vega of the Ad hoc Strategic Plan Review to explain the changes to the Plan that he had been working on.
- President Ocnaschek explained to the membership proposed changes to the Honorary Membership process. For a member to be brought for Honorary Membership, the member must have rendered distinguished service specifically to the Association versus service for the former employer. Nominations for honorary membership shall be made to the Board of Directors in writing and shall articulate accomplishments and service to the Association warranting this honor. This change will too be voted on in the September meeting.
- President Ocnaschek then recognized Mark Czerwick who was recently made an Honorary Member.
